Rules and Regulations:

- 1) All golfers must be finished golfing at an appropriate time. 9 holes 2.25 hrs, 18 holes 4.5 hrs, and an additional cost will be applied if tournament last longer.
- 2) Confirmation of 14 days in advanced for the number of people attending event. Coordinator will be charged for no shows.
- 3) Payment should be in cash or check form... Credit cards will be additional 2%.
- 4) Payment is required an hour prior to event.
- 5) Rain, cold, or generally lousy weather conditions are not grounds for cancellation. If the course is open you are expected to play. If conditions are dangerous, unplayable, or the superintendent has closed the course, we can schedule an alternative date or you can be issued a refund of any unused, nonperishable services and goods.
- 6) In order to provide the best possible service it is necessary that we receive a pairing sheet with names a day prior to event. Badlands Golf Course will then assign cart and hole assignments.
- 7) Everyone must be ready to tee off 15 minutes prior to tee time or there will be an additional charge for the delay.
- 8) Event coordinator will be held responsible for any damages that may occur to the Badlands Golf Course property.
- 9) All alcohol must be purchased from Badlands Golf Course (any "carry on" beverages not purchased from the club will be confiscated).
- 10) We reserve the right to ask individuals to leave with no refunds.
